EXAMINATION / TREATMENT REPORT

UNCONDITIONAL AND WITHOUT PREJUDICE

Structural Condition

The canvas is lined and is securely attached to a keyed wooden stretcher. This is providing a stable structural support. There are old labels adhered to the upper horizontal and central vertical stretcher-bars.

Paint Surface

The paint surface has an even varnish layer.

The paint surface appears entirely stable.

Inspection under ultra-violet light shows a t-shaped retouching in the upper left quadrant of the composition which measures approximately 6 cm by 10.5 cm. There are also a few further very small spots of retouching within the foreground.

Summary

The painting would therefore appear to be in good and stable condition and no further work is required.
